

THE DRAWING STUDIO CALL FOR ENTRIES
“A Thousand Whispers”

The Drawing Studio invites entries for a juried exhibit of abstract paintings by artists who have participated in abstract painting studio classes at TDS. The exhibit is scheduled for March 6 – April 17, 2010. Exhibit co-chairs are Lisa Mishler and Emilia Arana. Additional Jurors will be Josh Goldberg and Carolyn Gibbs.

A maximum of two entries are allowed per person. Entry fee is \$10 for Associate members of TDS and \$15 for non-members, payable by check, cash or credit card. Please submit 300 dpi JPG images on a CD, and mail or deliver to The Drawing Studio, ATTN: Abstract Exhibit, 33 S. Sixth Avenue, Tucson 85701-1805, along with the entry form and liability waiver. CD's can be returned only if accompanied by a postage paid envelope. Digital images can also be e-mailed to Mishler or Arana, with paperwork mailed or delivered to TDS.

Work on paper, board, or canvas is eligible, with a maximum width of 48". Canvas works should be on gallery wrap stretcher bars. Work on narrow stretcher bars should not be submitted for consideration. Works on paper that are selected must be appropriately framed with ample white mats and simple framing in excellent condition. Works not properly framed can be refused. Works on board should also be appropriately mounted to approximate the depth of gallery-wrap canvas. All works should be wired and ready to hang.

Any works sold will be subject to a 40% commission

- **January 21, 2010** – entries due at TDS by mail or hand-delivery. See attached form.
- **Week of February 1** – materials and acceptance notifications mailed to entrants
- **March 2, 2010** -Accepted entries due at TDS 10 am – 2 pm
- **March 6, 2010** - Exhibit reception from 6 – 9 pm
- **April 18 and 19** -Unsold works can be picked up between 10 am and 1 pm.
